



W2 – Financial Assistance – HOPWA

HOPWA Permanent Housing Placement (PHP) and Short-Term Rent, Mortgage Utility (STRMU) projects are required to track financial assistance by recording the Financial Assistance Type, Date of Financial Assistance and Financial Assistance Amount. Record for the Head of Household ONLY each time the Financial Assistance is provided.

SSVF Projects for both Rapid Re-Housing and Homelessness Prevention are required to track financial assistance by recording the Financial Assistance Type, Date of Financial Assistance and Financial Assistance Amount. Record for the Head of Household ONLY each time the Financial Assistance is provided unless the assistance is directed at a specific member of the household.
